**IS YOUR ACCOUNT INFORMATION UP TO DATE?**

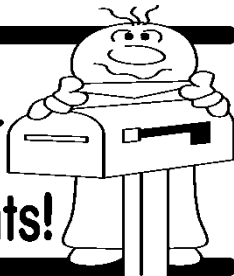
Do we have your current address, phone number or email?
