January 2021

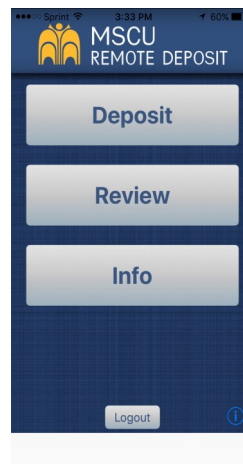
Available thru December 31st
